## When does registration open for the NAR NXT, The REALTOR® Experience?

- Registration launches at 12:00pm CST on Wednesday, May 18 for all members. We will not have a separate opening date for the Official Family.
- All attendees, including those that serve committees, must register using one of the categories listed <a href="https://example.com/here">here</a>. There is no Governance Only registration.
- AEs can register more than one member on the same registration with one payment. The only
  exception: REGISTER YOUR DIRECTORS WHO ARE GUARANTEED AT THE HEADQUARTER HOTEL
  SEPARATELY AS ONE REGISTRATION. Hotel selections are saved in your cart during entire
  process, including while adding additional registrants and events. Hotel is confirmed only when
  registration is completed and credit card guarantee is provided. If you did not receive your firstchoice hotel, be sure to use the waitlist function to be added to the list for your desired hotel.
